Leasehold Management

Common in England and Wales, leaseholders own the right to live in a property for a fixed term. Most leasehold homes are flats, with shared areas like hallways, roofs, and gardens managed by a block property manager on behalf of the freeholder. Leaseholders also pay a service charge for upkeep.

Build to Rent

Build to Rent developments are owned by a single individual or company and rented out to tenants. A property manager oversees all aspects of the development, from communal areas to individual flats, acting on behalf of the landlord.

Factoring

In Scotland, block management is known as factoring. Flat owners jointly own and maintain the building, often hiring a professional 'factor' to manage it.
